AUTHORIZED USER AGREEMENT

ASURACOM Limited, a company organized and existing under the laws of [REDACTED], with its principal place of business located at [REDACTED], hereinafter referred to as "ASURACOM," serves as the host entity responsible for providing access to the Auralink Secure Cognition Management (ASCM) software ("Software") under the terms and conditions outlined in this Authorized User Agreement ("Agreement"). ASURACOM is committed to facilitating the secure and responsible utilization of the Software by authorized users, ensuring compliance with all applicable laws, regulations, and internal policies governing its operation and use. Users are advised to direct any inquiries, concerns, or notices regarding the Software or this Agreement to ASURACOM's designated legal representative provided in section 3A of the user-provided "Ascension Confirmation" document.

This Authorized User Agreement ("Agreement") governs the relationship between the undersigned individual ("User") and the entity providing access to the Auralink Secure Cognition Management (ASCM) software ("Provider"). By authenticating, User acknowledges and agrees to be bound by the terms and conditions set forth herein.

1. ACKNOWLEDGEMENT OF AUTHORIZATION: User hereby acknowledges and affirms their status as an authorized ASCM user, duly authorized by Provider to access and utilize the ASCM software for designated purposes.

2. INFORMED CONSENT: User affirms that they have undergone comprehensive briefing and information dissemination sessions conducted by a duly appointed local agent, thereby ensuring that User possesses a clear understanding of the functionalities and risks associated with utilizing any ASCM software.

3. RISK ASSESSMENT: User acknowledges and fully comprehends the inherent risks associated with the utilization of ASCM software, including but not limited to the potential manifestation of adverse physiological reactions such as seizures, strokes, difficulties in respiration, cognitive impairments, and aura rot.

4. CONFIDENTIALITY: User agrees to maintain strict confidentiality regarding their account details, including user ID and authentication key, refraining from sharing such sensitive information with any external parties without the express authorization of Provider.

5. NON-DISCLOSURE: User further agrees not to disclose, display, or demonstrate ASCM software to any external parties, thereby safeguarding the proprietary nature of the technology and protecting against unauthorized dissemination or exploitation.

6. SECURITY OBLIGATIONS: User assumes full responsibility for the security and integrity of their user ID and authentication key, undertaking to employ all reasonable measures to prevent unauthorized access, misuse, or compromise thereof.

7. PROPER USAGE: User commits to the proper and responsible utilization of ASCM software, including the conscientious closure of all instances thereof upon the completion of designated tasks or when not actively in use, thereby mitigating the risk of unauthorized access or potential security breaches.

8. COMPLIANCE: User agrees to adhere strictly to all applicable laws, regulations, and internal policies governing the use of ASCM software, ensuring compliance with all legal and regulatory frameworks relevant to their jurisdiction.

9. LIMITATION OF LIABILITY: User expressly acknowledges and agrees that Provider shall not be held liable for any damages, losses, injuries, or adverse consequences arising from the use or misuse of ASCM software, including but not limited to those enumerated in section 3 above.

10. TERMINATION: Provider reserves the unilateral right to terminate User's access to ASCM software at any time, with or without cause, and without prior notice, thereby ensuring the preservation of Provider's prerogative to manage access to its proprietary technology.

11. GOVERNING LAW: This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction in which Provider operates, without regard to its conflict of law principles, thereby ensuring the establishment of a clear legal framework for the interpretation and enforcement of the terms herein.

12. ENTIRE AGREEMENT: This Agreement constitutes the entire understanding and agreement between User and Provider concerning the subject matter hereof, supplanting and superseding all prior or contemporaneous agreements, understandings, or communications, whether oral or written, pertaining to the utilization of ASCM software.
